Active ETF refers to investment strategies that emphasize the use of alternative weighting schemes to traditional ETF tracking market capitalization based indices. Market Capitalization is the value of the fund as determined by the market price of its issued and outstanding stock. The Weighted Average Market Capitalization of a portfolio equals the average of each holding's market cap, weighted by its relative position size in the portfolio (in such a weighting scheme, larger positions have a greater influence on the calculation). Price-Book Ratio (P/B Ratio) is used to compare a firm's market capitalization to its book value. It's calculated by dividing the company's stock price per share by its book value per share (BVPS). Price-Sales Ratio (P/S Ratio) is a valuation ratio that compares a company's stock price to the value that financial markets have placed on each dollar of a company's sales or revenues. Price-Free Cash Flow Ratio (P/FCF Ratio) is a valuation ratio that compares a company's stock price to the cash generated after considering money required to maintain or expand company assets. Profit Margin is the percentage of a company's revenues that maintained as net income. Debt/Capital is a leverage ratio that compares the company's interest-bearing debt, both short- and long-term liabilities and dividing it by the total capital.

S&P GSCI is a composite index of commodities that measures the performance of the commodity market. The S&P GSCI is the commodity equivalent of stock indexes, such as the S&P 500 and the Dow Jones. The MSCI ACWI All Cap Index covers more than 14,000 securities and includes large, mid, small, and micro-cap size segments for all developed markets countries plus large, mid and small-cap size segments for emerging markets. The S&P 500 Index represents an unmanaged, broad-based basket of stocks.
